OFFICIAL RULES
i3-DBS, LLC (“PaySchools” or “Sponsor”)

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Trays Across America School Give Back Program (“Sweepstakes”) begins on September 11, 2019 at 12:00 AM Mountain Time (“MT”) and ends on November 8, 2019 at 12:00 AM MT (“Promotion Period”). The time shall be determined by Sponsor’s timekeeping systems. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

Open only to PaySchools school districts using PaySchools QuikApps account as of date of entry. Void wherever prohibited by law. By participating, districts agree to be bound by these Official Rules and the decisions of Sponsor. A PaySchools QuikApps application is free and may be obtained and completed by a parent through a current PaySchools account.

TO ENTER: During the Promotion Period, districts may enter the Sweepstakes by encouraging parents in their district to do the following:

- 1) visit www.payschoolscentral.com; or www.payschoolsadmin.com
- 2) Fill out the full free and reduced lunch application

PaySchools will set aside 5 cents per application, up to a total of \$2,500.

Entry is limited to 1 per district. One prize will be given at the end of the Sweepstakes to one randomly chosen district. No mechanically reproduced entries of any kind permitted. Incomplete entries are void. Entries become the property of Sponsor and will not be returned.

WINNER SELECTION: The winning district will be selected by random drawing on or about November 1, 2019 from all eligible entries received. Decisions of Sponsor are final on all matters. Odds will depend on how many districts are entered in the Sweepstakes.

PRIZE: Upon verification of eligibility and compliance with these rules, 5 cents per application received will be totaled and awarded to the district chosen (up to \$2,500 total) to be used solely to defray costs of the free and reduced lunch program in the district. Each eligible entry shall be assigned a discrete random number from which the randomized selection will occur.

Federal, state, and local taxes on prizes, if any, and any other costs, fees and expenses not listed above as specifically included as part of the prize are the sole responsibility of winner. **ALL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNER.** An IRS form 1099 and other tax-related forms and documents may be issued by Sponsor.

WINNER NOTIFICATION AND RELEASES: On or around November 14, 2019, Sponsor shall notify the potential winner. If the potential winner does not respond after the first attempted contact from Sponsor within 48 hours, it will be disqualified, and the prize awarded to an alternate winner as determined by random draw from the remaining eligible entries. Acceptance of the prize constitutes permission to the Sponsor to use winning district’s name for

purposes of advertising and trade, in any medium, without further compensation, unless prohibited by law.

Sponsor reserves the right to disqualify, freeze or prohibit the participation of an entrant if fraud or tampering is suspected, or if the entrant fails to comply with any requirement of participation or with any provision in these Official Rules.

GOVERNING LAW & JURISDICTION: EXCEPT WHERE PROHIBITED, ENTRANTS AGREE THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS PROMOTION SHALL BE RESOLVED EXCLUSIVELY BY IN THE COURTS OF TENNESSEE LOCATED IN DAVIDSON COUNTY, TENNESSEE, AND ANY AND ALL CLAIMS, JUDGEMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED BY ENTRANT WITH REGARD TO THIS PROMOTION, BUT IN NO EVENT ATTORNEYS' FEES, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES. SEVERABILITY: If any provision(s) of these Official Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
